# 1. Previous minutes and matters arising

Corrections – Vidyamala was present but listed under apologies Minutes were otherwise accepted as correct

### **Matters Arising**

Annual report and account

- 1) Appointment of alternative independent examiner completed
- 2) Public liability insurance not researched: The ECA is a company limited by guarantee, so liability isreduced
- 3) Possibility of changing the accountant period: pending, waiting for start of new finance officer
- 4) Risk management: pending and waiting for new finance officer

Under 6) bookkeeper /finance officer post update: post was advertised in October, several applications received which were not deemed suitable. Plan to have post filed by end of month and start of work end of March 2016

7 e) Child protection and vulnerable adults – update: these policies are in process and have happened/will happen. Suggestion that In addition to policy there might be need for <u>training</u> at centres and help with implementation to implement at centres - seen as next step.

### 2. Venues for future ECA meetings

In 2013 it was agreed to have all ECA at Adhisthana for a 2 year trial period; Only alternatives currently are Vajrasana and Padmaloka both available in summer and winter.

Based on results of survey, <u>Proposal</u> is that 1 in 4 meetings happen elsewhere other than at Adhisthana – i.e. one very other year. I.e.:

- > 2016 both booked at Adhisthana
- > Jan 2017 at Adhisthana
- Summer 2017 at Vajrasana

Agreed, with several abstentions

## 3. <u>Development Fund 2016 update</u>

Development Fund budget 2016 confirmed as agreed at August 2015 ECA. Guaranteed level of funding is being released to grant receiving projects and Amalavajra is confident of raising a further £25,000 to allow full funding of grants.

## A) International council sec support

ECA had some time ago agreed to contribute a third of support of the half-time post of the International Council secretary, a sum of £2,500. End of last year IC appointed a F/T sec, (Dhammamegha); request now is to contribute a third of fulltime post – ie £5000 in total

**Proposal**; to meet that cost for this year out of other income/unpaid bookkeeper post, and communicate that IC needs to formally request towards contribution for the post in 2017 if this is desired. (In long term this post may be funded through FD fund but this is a process of transition) **Proposal agreed** 

There was a**request** for more joined-up thinking on appointing any new member of the team i.e. checking it out with all the movement teams, as it has implications for others e.g. for Adhisthana; particularly if they need to live here.

### 4. Development Team report

Munisha, Amalavajra, Prajnaketu - report on their work during the course of the meeting

Other work DT has been involved in:

- International Urban Retreat MK with TBCO and Munisha
- Weekends for Groups and Pioneers –2 x year
- Groups DT completed a 'Survey of Groups in Europe' to find out what happens, what challenges they face and how the DT might support and help
- FDF setting up the new charity and application process etc
- Successful Fundraising by Amalavajra Bhante's birthday appeal to finance production of Complete
  Works as well as for Translations Fund; the appeal to top-up Bhante's ongoing support raised over
  the Aug 2015 OWE; and AV brought in additional funds for the College Appeal
- Planning for BAM 2016
- · Secretarial and general admin work

Recent proposal: that DT is an Order only team to help maintain effectiveness and harmony of that meeting

Other members of the DT fulfilling other functions like FR assistant (who might be OMs or mitras)will not be part of the DT core team meeting

DT developing an 'team ethos' so anyone joining the team is clear of the way we are working, a broader expression of the principles of the way we work; in addition to having a legal contract

Suggestion to insure Amalavajra (cf.Windhorse used to insure Vajraketu) as he seems such a key asset to the Movement - **exec to consider**.

Request to have Business Plan for the ECA **in writing**: what do we think we are doing in the next 5 years, who we are employing and for how long, etc.

### 5. Pension provision and National Living Wage

**Pensions**: Guidance on new statutory requirements (UK) – these need to be known and chairs need to make decisions on how to act on that and on what level to set the pensions

**National Living Wage**: the legal obligation is that even if you are not an hourly rate employers trustees need to be able to demonstrate that this minimum level is paid. The only exemption is for people living in residential religious communities and working in a charity clearly linked to it. (The only other exception is *possibly* minsters of religion who are not considered 'employees' in the usual sense.)

### 6. Data security and website security

Update on new legislation on data security: A number lot of Centre websites are not very secure/ get hacked and then produce spam; as a result the service provider gets black-listed - all this quite a lot of work for the dharmachakra team.

Good web security and a competent website management is essential: if this is not in place the TBCO team are offering to manage Centres website; they request centres to contact them if there are any doubts about web security. The TBCO are aiming to do this free of charge; as far as possible.

New European legislation re the holding of databases - currently the indication is that this is not an issue, but might be in the future.
